

Inventoried Roadless Areas (IRAs)

Proposed Facilities within IRAs

Current Conditions

- Thirteen IRAs within the analysis area are managed for roadless character. Under the Idaho Roadless Rule regulations, Payette National Forest and Boise National Forest plans, and 36 CFR 228A regulations, locatable mineral activities are allowed in the portions of these IRAs where proposed for the SGP, with mitigation of effects.

Mine Impacts/Protective Measures

- **Alternative 1:** 752 acres of Stibnite Gold Project (SGP) structures and facilities within six IRAs (Meadow Creek, Horse Heaven, Black Lake, Burntlog, Caton Lake, and Reeves Creek).
- **Alternative 2:** 740 acres of SGP structures and facilities within six IRAs (Meadow Creek, Horse Heaven, Black Lake, Burntlog, Caton Lake, and Reeves Creek).
- **Alternative 3:** 650 acres of SGP structures and facilities within six IRAs (Meadow Creek, Horse Heaven, Black Lake, Burntlog, Caton Lake, and Reeves Creek).
- **Alternative 4:** 531 acres of SGP structures and facilities within four IRAs (Meadow Creek, Horse Heaven, Caton Lake, and Reeves Creek).
- **Alternative 5:** No new facilities within IRAs.

Reclamation/Restoration/Mitigation

- **Alternative 1:** 491 acres of reclaimed mine features (tailings storage facility [TSF] and development rock storage facility [DRSFs]) to remain in Meadow Creek and Horse Heaven IRAs.
- **Alternative 2:** 524 acres of reclaimed mine features (TSF and DRSFs) to remain in Meadow Creek and Horse Heaven IRAs.
- **Alternative 3:** 455 acres of reclaimed mine features (TSF and DRSFs) to remain in Meadow Creek and Horse Heaven IRAs.
- **Alternative 4:** 491 acres of reclaimed mine features (TSF and DRSFs) to remain in Meadow Creek and Horse Heaven IRAs.
- **Alternative 5:** No new facilities within IRAs.

Net Change

- **Alternative 1:** 491 acres of reclaimed mine features in Meadow Creek and Horse Heaven IRAs.
- **Alternative 2:** 524 acres of reclaimed mine features in Meadow Creek and Horse Heaven IRAs.
- **Alternative 3:** 455 acres of reclaimed mine features in Meadow Creek and Horse Heaven IRAs.
- **Alternative 4:** 491 acres of reclaimed mine features in Meadow Creek and Horse Heaven IRAs.
- **Alternative 5:** No new facilities within IRAs.
